## DATA SHARING AGREEMENT

Thank you for supporting your local food supply chain by contributing your information to this interactive model. This agreement is designed to inform those adding their organization's details to the Interactive Food Supply Chain Models hosted on foodsupplychain.ca.

**Definition of 'Data':** For the purposes of this agreement, 'data' refers to any information entered by the user into the food model data portals (forms found on foodsupplychain.ca), and any insights derived from analyzing that information. You may not include any personal information in the data you provide to us.

Ownership & Management of Data: The data being entered by the user will be owned and managed by TruGIS Web and Geospatial Services, and its affiliated entities including but not limited to TruGIS Mapping and Drone Services (TruGIS). The user may enter as much or as little data as they desire. By entering the data, you grant TruGIS a world-wide, royalty free, perpetual, irrevocable, fully paid-up, non-exclusive license to use, process, adapt, reproduce, modify, publish, transmit, display and distribute the data without compensation to you.

**Usage of Data:** Information entered by the user may be used for various purposes, including the following:

- To inform decision-making policies related to food supply chains and improve local economic resilience.

- To enable continuous enhancements to the model, foster the creation of new tools, and steer its future development.
- To contribute to an expanding network of supply chain representations.
